The Director of Child Support Services requests the County Board's approval to contract with 16 partner agencies in order to provide curriculum, training, and other services related to the Administration for Children and Families New Pathways for Fathers and Families grant. Child Support Services will receive \$10 million for the period of 9/30/2015 through 9/29/2020. For the grant period, \$447,862 will be retained by Milwaukee County Child Support Services per year for the 5 year grant period. The 16 partner agencies will divide \$1,552,138 per year, for the 5 year grant, for their grant activities. The 2016 CSS budget includes these funds.
