Amendment and Extension of Contract for Services Between Milwaukee County and the Benedict Center

Whereas, the Superintendent of the House of Correction has been satisfied with the "Reentry Project" services being provided by the Benedict Center (the "Contractor") pursuant to a contract in effect since approximately April 1, 2014; and

Whereas, the Contractor and the County desire to expand the scope of services to be provided by Contractor under the contract and desire to extend the term of the contract; and

Whereas, this contract and any contract extension are contingent upon approval and provision of annual funding by the Milwaukee County Board of Supervisors;

NOW, THEREFORE, subject to approval and provision of annual funding by the Milwaukee County Board of Supervisors, the County and Contractor do mutually agree as follows:

- To increase staffing provided by Contractor for these services from one full-time equivalent (FTE) to two FTEs in order to provide services to approximately 150 females.
- To expand the scope of services provided by Contractor to include curriculum for:
 - o Cognitive Behavioral Therapy
 - o Anger / Stress
 - Nurturing & Parenting
- To continue to include in the scope of services provided by Contractor the additional gender responsive group counseling that is designed to reduce women's risk of recidivism. These groups include Seeking Safety (trauma), Life Skills and Women's Sexuality (for women in the sex trade, prostitution and sex trafficking).
- The contract term will be extended from January 1, 2016 to December 31, 2016.
- The total direct compensation to the Contractor shall be \$155,000 per calendar year, which shall be paid with one lump sum payment on December 15, 2015; and,
- The DBE amount will be \$1,000 for 2016.
- All previous executed contract stipulation, requirements, duties and responsibilities, not
 inconsistent with this amendment and extension, will remain in force for the duration of this
 contract.

THE BENEDICT CENTER AND MILWAUKEE COUNTY HAVE EXECUTED THIS CONTRACT EXTENSION EFFECTIVE $_^{10/13/2015}$.
