WHEREAS, the Director, Department of Health and Human Services, is requesting authorization to execute Purchase of Service contracts with a variety of community vendors for 2016; and

WHEREAS, over the past several years, the Delinquency and Court Services Division has entered into a series of Purchase of Service contracts to support essential program activities and functions; and

WHEREAS, in accordance with Milwaukee County's Request for Proposals process, the providers named below are being recommended to provide their respective services during 2016; and

WHEREAS, the Committee on Health and Human Needs, at its meeting of December 9, 2015, considered this item for informational purposes only; and

WHEREAS, the Committee on Finance, Personnel, and Audit, at its meeting of December 10, 2015, recommended adoption of the Director's request (vote 7-0); now, therefore,
