WHEREAS, the Committee on Finance, Personnel, and Audit (Committee) typically reviews each month a report from the Office of Performance, Strategy, and Budget (OPSB), Department of Administrative Services (DAS), recommending appropriation transfers that modify the Adopted Budget to reflect revised expenditures and revenues related to information that was not available at the time the original budget was adopted; and

 WHEREAS, the Committee reviewed the recommended appropriation transfers at its meeting of December 10, 2015, and expressed concerns about a transfer reallocating salary appropriations for three separate staff assigned to other divisions or departments but yet effectively working for the Central Business Office (CBO), DAS, since the beginning of 2015; and

WHEREAS, the affected staff include:

Accountant 1 (from the Office of Emergency Management)

 Coordinator Administrative (from the Real Estate Services Division, DAS)

 Clerical Specialist Information Management Services Division (IMSD) (from IMSD, DAS)

; and

WHEREAS, the 2015 Adopted Budget should have reflected the assignment of these positions to the CBO, DAS, as the individuals in these three positions have worked there since the beginning of 2015, contrary to the placement of the positions approved by policymakers in the Adopted Budget; and

WHEREAS, alternatively, an appropriation transfer should have been submitted earlier in 2015 so that policymakers could approve the transfer of these positions to the CBO, DAS, from the organizational units in which they were originally assigned in the 2015 Adopted Budget; and

WHEREAS, the three positions have been officially transferred to the CBO, DAS, beginning January 1, 2016, as part of the 2016 Adopted Budget; and
