### Referrals Received from the County Board Chairperson for the County Board Meeting on September 26, 2013

- 13-652 A resolution by Supervisors Weishan, Jr., and Stamper II, directing the County Executive to negotiate an Intergovernmental Agreement between the City of Milwaukee and Milwaukee County for the operation and regulation of taxicab service.

- 13-657 A resolution by Supervisor Jursik, endorsing the Southeastern Wisconsin Regional Planning Commission's 2035 Regional Housing Plan for Southeastern Wisconsin.

- 13-698 A resolution by Supervisor Bowen, requesting a report from the United States Department of Justice to the Milwaukee County Community Business Development Partners Office regarding the impact of minority business and minority hiring goals for projects in the Milwaukee metropolitan area that utilize federal Stimulus funds.
