A. The Department of Transporation is requesting the creation of a new capital project for the purpose of project development for the proposed Bus Rapid Transit (BRT) project that is under consideration.

- B. Federal Transit Administation (FTA) 5307 formula funds are provided to Milwaukee County and can be used for capital projects such as the proposed BRT project. In order to enter project development with the FTA, Milwaukee County needs to demonstrate that it has sufficient funds available to complete project development. The amount requested to demonstrate this is 7% of the project cost which is currently estimated at \$40,000,000. A 7% planning and design would be \$2,800,000 of which Milwaukee County, MCTS and SEWRPC already has \$610,000 available, therefore, a request of \$2,190,000 of 5307 would be needed to make up the difference.
- C. The amount of 5307 funds requested are federally available and currently not allocated toward any project in 2016. Therefore, these funds are available and the allocation of these funds would not impact any project currently budgeted for 2016. Should the BRT project not move forward for any reason, the amount of any unspent funds could be re-programmed for future capital needs in future years.
