The district attorney's office is requesting permission to apply for additional Victims of Crime Act (VOCA) grant funding of approximately $\$ 140,908$ ( $\$ 112,727$ federal $+\$ 28,181$ local match), from October 1, 2016, to September 30, 2017, for the salaries and fringe benefits of two new positions - a victim/witness advocate in the domestic violence unit at the Sojourner Family Peace Center and a sensitive crimes victim advocate in the sensitive crimes unit - and computer equipment for the new positions.

Acceptance of the additional VOCA grant funding, if awarded, will have no 2016 tax levy effect because the district attorney's office should be able to absorb the estimated local match expenses of $\$ 7,415$ within its 2016 operating budget. No appropriation of funds is required in the 2016 budget. The district attorney's office will request funding for the new positions in the 2017 budget, including the estimated local match expenses of $\$ 20,766$.
