- A. The approval of the requested action will allow IMSD to contract with Northwoods Software for the branding, redesign and rebuild of Milwaukee County's internet and intranet. This action will result in a capital cost of \$194,155 to Northwoods Software for efforts involved in the rebranding and rebuilding of the internet/intranet as a managed service provider. The project will also consist of project management, security optimization, and 20% contingency allocation for a total project cost of \$450,000. As the discovery phase of the project concludes, there may be additional functionality or services identified thus a 20% contingency was accounted for in the overall project cost. The Milwaukee County Internet/Intranet Redesign Rebuild will be funded through the capital project WO632.
- B. IMSD has appropriated funds in 2016 to plan, design, and implement a solution for this rebranding and rebuilding effort.
- C. IMSD has appropriated funds in 2016 for the implementation of this rebranding and rebuilding effort. The project is expected to be completed within eight (8) months from kick-off.
- D. IMSD has used vendor proposals to estimate the transition costs associated with this project. Additionally, the on-going cost estimate is based on the current state footprint (number of servers and storage resources) of Milwaukee County's infrastructure environment.
