  - A. Approval of the request would create 1.0 FTE Human Service Worker
  - B. The current year fiscal impact is an increase of \$15,931 in salary and social security costs, and \$7,944 in active health and pension costs. In subsequent years, additional operating expenses of \$56,432 annually will need to be absorbed by the agency.
  - C. Sufficient funds exist in the Department of Health and Human Services 2016 operating budget to fund the requested position. For 2016, as well as, in subsequent years, the Department of Health and Human Services will need to ensure the cost of this position is absorbed into their operating budget. The remaining costs for this position will be covered by 2016 fund currently budgeted for vacant, funded positions.
  - D. This fiscal note assumes the rate of pay for 11 pay periods of 2016 at Step 1 of Pay Range 16C. An additional 1% COLA increase in July 2016 was included in this position cost estimate.
