AMENDMENT TO PROFESSIONAL SERVICE CONTRACT

Milwaukee County, a Wisconsin municipal body corporate (hereinafter called "County"), represented by Paul Bargren, Corporation Counsel, and Whyte Hirschboeck Dudek SC (hereinafter called "Contractor") entered into a contract for professional services for the case *Wosinski et al v. Advance Case Stone et al.* Case No. 11-CV-1003 in December, 2011 (the "Contract"). The parties hereby agree to amend that contract, as follows:

COMPENSATION

The Compensation section of the Contract is hereby amended to provide that the total compensation to Contractor for services performed under the Contract shall not exceed Three hundred forty thousand dollars (\$340,000) unless agreed to by County in writing. At such time as the compensation for Contractor's services approaches Three hundred thirty five thousand dollars (\$335,000), Contractors and County will discuss entering into an extension or amendment of this Contract.

Except as set forth above, all provisions of the Contract and prior Amendments between the parties remain in force and effect.
