15 16 17	WHEREAS, the O'Donnell Park parking structure was closed for an extended period of time, resulting in a loss of revenue to Milwaukee County (the County), and extensive repairs were required to the structure at a significant cost to the County; and
18 19 20 21 22 23	WHEREAS, various parties have filed multiple suits against the County and others related to the death and injuries that occurred and Whyte Hirschboeck Dudek S.C. (WHD), has been retained by the Wisconsin County Mutual Insurance Corporation to represent and defend the County's interests in those lawsuits; and
23 24 25 26	WHEREAS, WHD acquired extensive knowledge and experience of the facts and issues related to the parking structure construction, repair, and related matters; and
20 27 28 29	WHEREAS, WHD has extensive specialized knowledge and experience in the area of construction litigation; and
30 31 32 33 34	WHEREAS, it is advantageous to the County to maintain the services of WHD to utilize its general legal experience and its specific legal experience related to the parking structure in order to prosecute the County's appellate claims against potentially responsible parties for loss or damages relating to the failure of the O'Donnell Park parking structure; and
35 36 37 38 39	WHEREAS, Corporation Counsel has negotiated a contract that provides for a discounted hourly rate not to exceed \$220, and in the event of a recovery by the County, a reduced contingency fee offset by any fees paid at the hourly rate; and
40 41 42 43	WHEREAS, several amendments have been made to this contract, with the last amendment in September of 2015, increasing the contract to \$290,000, which has now been expended; and
43 44 45 46	WHEREAS, Corporation Counsel requests authorization to increase the potential fees to be paid under this contract by \$50,000, to a total authorization of \$340,000; and

- WHEREAS, there are sufficient funds in Org. Unit 1961-Litigation Reserve 47 Account, to pay for the legal services described in this resolution; and 48 49
- 50 WHEREAS, the Committee on Finance and Audit, at its meeting of June 16, 51 2016, recommended adoption of Corporation Counsel's request (vote 7-0); now,
