20 21 22 23	WHEREAS, DC48 filed suit in Federal court against the County alleging they were laid off as a result of exercising their right to freedom of association as well as their union status and activities; and

26 27 28 29	WHEREAS, the County denies the allegations, but has been unable to approve a settlement agreement that is acceptable to all parties; and
