Stats. 30 or county executive appointment confirmations subject to s. 59.17(2)(b)(1) Wis. 31 Stats. 32 33 SECTION 2. Section 1.15 of the General Ordinances of Milwaukee County is amended 34 as follows: 35 36 1.15. - Referring resolution, ordinance or report for legal opinion. 37 38 With the affirmative vote of one-third (1/3) of the members present and voting at 39 any meeting of the county board, any resolution, ordinance or report shall be referred to 40 the corporation counsel and the written opinion of the latter secured as to the legality of 41 the resolution or ordinance offered, or the recommendation made in any report 42 presented to the county board for adoption. Such opinion shall be rendered to the 43 county board at its next meeting held not less than forty-eight (48) hours after the 44 referral, and copies distributed to all members.
