### **Project Objectives**

- Coordinate with work to be conducted under 10 Year Comprehensive Parks System Master Plan
  - Benchmark analysis of peer agencies
  - Demographic analysis of potential outdoor recreation participation
  - Operation, financial, and organizational structure review
  - Funding and revenue analysis
  - Resident survey of needs and preferences
  - Public outreach and involvement including leadership interviews, focus groups, and public forums
  - Development of park facility standards
  - Park and Facilities Inventory and Condition Assessment
  - Existing year 2010 Level of Service (LOS) analysis/mapping of parks and key park facilities, and comparison of LOS to population density
- Project park facility needs based upon year 2050 anticipated growth, including consideration of the growth anticipated in the comprehensive plans of the 19 Milwaukee County municipalities.
- Consider the park facility recommendations of other planning efforts including the 10 Year Master Plan, municipal comprehensive plans, State and regional plans, and County park and park facility plans.
- Assess the LOS of County park facilities under projected year 2050 conditions, including LOS mapping and comparisons to anticipated year 2050 population density.
- Develop a year 2050 Park and Open Space Plan which will incorporate the recommendations of the 10 Year Master Plan and extend these recommendations for an additional 25 years.
