9	This Agreement, made and entered into by and between the County of Milwaukee, a municipal
10	body corporate, as municipal employer, hereinafter referred to as "County" and Technicians,
11	Engineers and Architects of Milwaukee County, as representatives of employees who are
12	employed by the County of Milwaukee, hereinafter referred to as "Association".
13	
14	WITNESSETH
15	
16	In consideration of the mutual covenants herein contained, the parties hereto do hereby mutually
17	agree as follows:
18	PART 1
19	1.01 RECOGNITION
20	The County of Milwaukee agrees to recognize and herewith does recognize Technicians,
21	Engineers and Architects of Milwaukee County as the exclusive collective Bargaining agent of
22	behalf of the Employees of Milwaukee County in accordance with the certification of the

1	Wisconsin Employment Relations Commission, as amended, in respect to wages, pursuant to
2	Subchapter IV, Chapter 111.40, Wisconsin Statues.
3	
4	1.02 EMPLOYEE DEFINED
5	Wherever the term "employee" is used in this Agreement, it shall mean and include only those
6	employees of Milwaukee County within the certified bargaining unit represented by the
7	Association.
8	
9	1.03 DURATION OF AGREEMENT
10	(1) After ratification by the parties the provision of this Agreement shall become effective
11	January 1, 2016, unless otherwise herein provided. Unless otherwise modified or
12	extended by mutual agreement of the parties, this Agreement shall expire on December
13	31, 2016.
14	(2) The initial bargaining proposals for a successor agreement shall be submitted by the
15	Association prior to August 15, 2016. The initial bargaining proposals shall be
16	submitted by the County prior to September 15, 2016. The first scheduled negotiations
17	session shall be held no later than October 15, 2016. Thereafter, negotiations shall be
18	carried on in an expeditious manner and shall continue until all bargainable issues
19	between the parties have been resolved.
20	(3) The timetable is subject to adjustment by mutual agreement of the parties consistent
21	with the progress of negotiations.

1	PART 2
2	The provisions of this Part 2 shall become effective in accordance with Part 1 unless otherwise
3	provided.
4	<u>2.01 WAGES</u>
5	(1) Effective Pay Period 8, 2016 (March 27, 2016), the wages of the bargaining unit employees
6	shall be increased by seven-tenths of a percent $(0.7\%)$ .
