17 18 19 20	WHEREAS, Federal agencies work through GLRI action plans to use GLRI's resources to strategically target the biggest threats to the Great Lakes ecosystem and to accelerate progress toward long-term goals; and
21 22	WHEREAS, a major focus is cleaning up 27 Areas of Concern (AOC) in the Great Lakes Basin, including the Milwaukee Estuary AOC; and
23 24 25	WHEREAS, the Wisconsin Department of Natural Resources (DNR) is tasked with implementing the AOC in Wisconsin; and
