13	WHEREAS, Wisconsin Stats §341.35 allows municipalities and counties to enact an
14	annual flat vehicle registration fee, which fees may only be used for transportation
15	related purposes; and

18	of Transportation will not be able to sustain its current levels of operation and capital
19	repairs; now, therefore,

21	BE IT RESOLVED, that in accordance with Wisconsin Stats §341.35 the Milwaukee
22	County Board of Supervisors adopts a county vehicle registration fee; and

34	Chapter XX of the Milwaukee County Code of General Ordinances is hereby created as

37	VEHICLE REGISTRATION FEE PROGRAM

39	XX-XX. Authority
40	This ordinance is adopted pursuant to the authority granted by Wisconsin
41	§341.35.

XX-XX. Purpose

The purpose of this ordinance is to provide Milwaukee County with a source of funds, in addition to other funding sources, for eligible transportation related activities defined within Wisconsin §341.35.

XX-XX. Definition.

In this section, "motor vehicle" means an automobile or motor truck registered under §341.25(1)(c), Wis. Stats, at a gross weight of not more than 8,000 pounds, that is registered in this state and is customarily kept in Milwaukee County.

XX-XX. Annual registration fee.

At the time a motor vehicle is first registered or at the time of registration renewal, the applicant shall pay a county vehicle registration fee of \$60. This fee is in addition to other fees required by Wisconsin Statutes Chapter 341. The Wisconsin Department of Transportation (DOT) shall collect the fee. Use of funds generated by this registration fee shall be restricted to supporting Milwaukee County transportation activities.

XX-XX. Exemptions.

The following motor vehicles are exempt from the annual vehicle registration fee:

(a) All vehicles exempted by Wisconsin Statutes Chapter 341 from payment of a state vehicle registration fee.

(b) All vehicles registered by the state under Wisconsin Statutes § 341.26 for a fee of \$5.

XX-XX. Replacements.

No county vehicle registration fee may be imposed on a motor vehicle which is a replacement for a motor vehicle for which a current county vehicle registration fee has been paid.

XX-XX. Administrative costs.

The Wisconsin Department of Transportation shall retain a portion of the moneys collected under this section equal to the actual administrative costs related to the collection of these fees.

Section 2.

The provisions of this Ordinance shall become effective upon passage.

 BE IT FURTHER RESOLVED, that the Milwaukee County Board of Supervisors hereby directs the Office of Governmental Affairs to lobby the State of Wisconsin legislature to modify Wisconsin Statutes Chapter 341 to base the Vehicle Registration Fee on the value of the vehicle and also to fully fund local transportation needs.

BE IT FURTHER RESOLVED, that the County Executive shall convene a public/private task force to consider ways to moderate the impact on low income households.
