2016 Accomplishments

- Development of the 2050 Park & Open Space Plan (update to 1991 version) and the 10-year Park System Master Plan (30% complete)
- Completed Dineen Park and Copernicus Park master plans; Jackson, Wilson, Lyons, Pulaski-Milw, KK Sports, KK Simmons at 90% completion
- Successful Traveling Beer Garden Tours: Roll Out the Barrel Tour, Pass Me the Pint Tour
- China Lights Boerner, Brighter than Ever
- RampUp Milwaukee at Red Arrow, Bradford, and Wilson (The Ability Center & OPD)
- Awarded nine projects totaling ~\$200k in matching funds from the PAMF
- Executed a MOU with the Friends of Boerner Botanical Gardens, Inc.
- Working towards national accreditation through the Commission for Accreditation of Park and Recreation Agencies (CAPRA) by demonstrating compliance with 151 standards in 10 operational areas (28% complete).













2016 Accomplishments (cont'd)

- Worked with Hunger Task Force, UWM County Cooperative Extension and Growing Power, providing the Sowing, Empowering and Eliminating Deserts of food (SEED) program initiatives
- Installation of protective netting at Mitchell Park Horticultural Conservatory;
 Task Force to begin community planning process
- Supported the Strategic Action Plan for the Walker Square neighborhood in partnership with the City of Milwaukee
- Completed rezoning application of parkland controlled by the Parks Department
- Entered into Worksite and Young Adult Work Opportunity Agreements with Employ Milwaukee and United Neighborhood Centers of Milwaukee
- Accepted Great Lakes Restoration Initiative grant funding in the amount of \$1,400,000, for South Shore Water Quality, Kletzsch Park Dam Fish Passage, and the Little Menomonee River Corridor Habitat Restoration.

The Park Worker 3 seasonal positions increase to 151 FTEs in 2017, due to the transfer of 111.2 positions from the Park Worker 5 rate; more positions are able to be funded at the Park Worker 3 rates.













2017 Budget Highlights

- <u>SPA 1 Administration</u>: Additional revenue of \$304,000 to be raised by Development Officer for operations; \$240,000 included to begin implementation of replacing POS system in 2018; elimination of \$500,000 from the PAMF
- <u>SPA 2 Operations and Regions</u>: The loss of \$2.5 million in revenue from the O'Donnell parking structure and the Transit Center; reduction in utilities and maintenance of \$300,000; elimination of \$275,000 to improve ball diamonds; 15 Parks/Hwy shared positions converted to 12 full-time Parks Maintenance positions
- SPA 4 Golf: minor fee increases result in additional revenue \$24,000
- <u>SPA 5 Aquatics</u>: \$35,000 to address disparities in drowning fatalities; two seasonal life guard positions to full-time for ACA compliance
- <u>SPA 6 McKinley Marina</u>: proposed 2% increase in slip rental fees













2017 Budget Highlights (cont'd)

- <u>SPA 8 Community Centers</u>: minimal increases in rental rates, increased utilization in rentals; 2 seasonal positions to full-time for ACA compliance
- <u>SPA 11 Concessions</u>: growth in sales; addition of permanent beer garden on Root River Parkway; add a full-time Unit Coordinator to manage increased sites; 1 seasonal position to full-time for ACA compliance
- <u>SPA 13 Park Services</u>: minimal fee increases from rentals; 1 seasonal position to full-time for ACA compliance













2017 Key Initiatives

- Continue advancing 2050 Park & Open Space Plan and 10-year Park System Master Plan
- Organize Employee Engagement Initiative action planning
- Begin process of implementing new Point-of Sale (POS) system
- Develop a strategic plan of action to address drowning fatalities within Milwaukee County
- Continue work City of Milwaukee MOU for stormwater and park improvements (Dineen and Copernicus)
- Continue work of KK Watershed Restoration Plan (Jackson, KK Parkway, Pulaski, Wilson)
- Continue work on Oak Creek Watershed Restoration Plan (SEWRPC, South Milwaukee, MMSD)
- Continue work on national accreditation (CAPRA)
- Begin process of updating Trails Network Plan
- Expand RampUp MKE initiative

WP29001/02 - Kinnickinnic Parkway Reconstruction (\$1,739,000)

- 2017: Request for construction funding
- 2016: \$263,167 funded for design
- Public meeting scheduled for 10/27
- Considering alternative to reduce pavement footprint and increase green space
- Financing recommended from vehicle registration fee revenue
















WP29802 - South Shore Improvements Phase II (\$1,200,000)

- 2017: Request for construction funding for the balance of parking lot
- 2016: \$1,606,209 for parking lot, starting at the south end
- 2016: Waterways Grant for \$800,000
- 2016: MMSD Green Infrastructure Grant for \$100,000
- Financing is recommended from General Obligation Bonds















WP32301 - Menomonee River Streambank Stabilization (\$300,000)

- 2017: Request for design and construction funding
- Hard toe installation to limit undercutting
- Upper bank bioengineering treatments
- Manipulation of mid-channel bar
- Financing is recommended from General Obligation Bonds
- Applying for grants to supplement County funding















WP48401 - Lake Park Ravine Bridge (\$2,500,000)

- 2017: Request for construction funding to replace bridge in kind
- 2017: \$500,000 financing recommended from vehicle registration fee revenue
- 2017: \$2,000,000 challenge for private contributions
- 2015: \$404,827 funded for design















WP52301 - Lake Park Steel Arch Bridge (\$100,800)

- 2017: Request for design funding
- Future: \$970,000 for construction
- Built in 1893 and features intricate steel work
- Reconstructed bridge will be reduces in width, similar to Lions Bridges
- Financing recommended from vehicle registration fee revenue
