12	The County Board of Supervisors of the County of Milwaukee does ordain as

15	SECTION 1. Chapter 66 of the Milwaukee County Code of General Ordinances is

18	VEHICLE REGISTRATION FEE PROGRAM

20	66.01. –Authority.
21	This ordinance is adopted pursuant to the authority granted by Wisconsin
22	<u>§341.35.</u>
23	
24	66.02Purpose.
25	The purpose of this ordinance is to provide Milwaukee County with a source of
26	funds, in addition to other funding sources, for eligible transportation related
27	activities defined within Wisconsin §341.35.
28	
29	66.03Definition.
30	In this section, "motor vehicle" means an automobile or motor truck registered
31	under §341.25(1)(c), Wis. Stats, at a gross weight of not more than 8,000
32	pounds, that is registered in this state and is customarily kept in Milwaukee
33	<u>County.</u>
34 35	66.04Annual registration fee.
36	At the time a motor vehicle is first registered or at the time of registration renewal,
37	the applicant shall pay a county vehicle registration fee of \$30. This fee is in
38	addition to other fees required by Wisconsin Statutes Chapter 341. The
39	Wisconsin Department of Transportation (DOT) shall collect the fee. Use of funds
40	generated by this registration fee shall be restricted to supporting Milwaukee
41	County transportation activities.
42	
43	66.05Exemptions.
44	The following motor vehicles are exempt from the annual vehicle registration fee:
45	-

46	(a) All vehicles exempted by Wisconsin Statutes Chapter 341 from
47	payment of a state vehicle registration fee.
48	
49	(b) All vehicles registered by the state under Wisconsin Statutes § 341.26
50	for a fee of \$5.
51	
52	66.06Replacements.
53	No county vehicle registration fee may be imposed on a motor vehicle which is a
54	replacement for a motor vehicle for which a current county vehicle registration
55	<u>fee has been paid.</u>
56	
57	66.07Administrative costs.
58	The Wisconsin Department of Transportation shall retain a portion of the moneys
59	collected under this section equal to the actual administrative costs related to the
60	collection of these fees.
61	
62	SECTION 2. The provisions of this amended ordinance shall be effective upon passage
63	and publication.
