- A. The Director of the Department of Health and Human Services (DHHS) is requesting authorization to execute 2017 Delinquency and Court Services Division (DCSD) purchase of service contracts with community vendors.

Approval of this request will allow the Director of DHHS to execute purchase of service contracts to continue provision of contracted Community Service & Restitution Coordination, the Evening Reporting Center, Level II In-Home Monitoring Services with Optional GPS, Targeted Monitoring services, Prevention and After Care, Shelter Care, Juvenile Educational Treatment Initiative (JETI), Community Connections services, Group Care, Community Accountability Panels for first-time juvenile offenders, the Saturday Alternative Sanctions Program and Re-Entry Coordination in DCSD for the period January 1, 2017 through December 31, 2017.

- B. Total 2017 expenditures included in this request are \$7,868,213.
- C. There is no tax levy impact associated with approval of this request in 2017 as funds sufficient to cover associated expenditures are included as part of DCSD's 2017 Budget.
- D. This fiscal note assumes expenditures will not exceed the amounts authorized for these purchase of service contracts.
