From the Chief Judge, First Judicial District, Combined Court Related Operations, requesting authorization to execute contracts relative to the Safety and Justice Challenge Phase II Implementation grant award received from the John D. and Catherine T. MacArthur Foundation for: a Safety and Justice Challenge Project Coordinator in the amount of \$127,500, effective for 18-months upon execution of the contract; and with the Medical College of Wisconsin in the amount of \$350,847 for data enhancements, for the period effective December 1, 2016, through May 31, 2018, by recommending adoption of the following:

A RESOLUTION

WHEREAS, on April 13, 2016, Milwaukee County (the County) received from the John D. and Catherine T. MacArthur Foundation a funding award notice for the Safety and Justice Challenge Phase II Implementation grant in the amount of \$2,000,000; and

WHEREAS, the award period is from May 1, 2016, to April 30, 2018, with the possibility to extend for an additional year; and

WHEREAS, on May 26, 2016, the Milwaukee County Board of Supervisors (County Board) adopted File No. 16-271, authorizing the Chief Judge to accept the Safety and Justice Challenge Phase II Implementation grant from the John D. and Catherine T. MacArthur Foundation (16-1601-150542-CJ) for the Safety and Justice Challenge Phase II; and

WHEREAS, on June 25, 2015, the County Board adopted File No. 15-412, authorizing the Chief Judge to accept the Safety and Justice Challenge Phase I Planning grant from the John D. and Catherine T. MacArthur Foundation (#108430) for the Safety and Justice Challenge Phase I; and

WHEREAS, the County submitted the Safety and Justice Challenge Phase II grant application on January 6, 2016, seeking funding for the provision of: technical assistance, book and release at Milwaukee Police Department district stations, enhancement of Crisis Assessment Response Teams, Crisis Mobile Teams, and Crisis Resource Centers, a stabilization unit for individuals with mental health issues, to address system heavy utilizers, the development of a trauma informed system, and data expansion; and

WHEREAS, the County will post and issue an 18-month contract, with the option to extend, for the Safety and Justice Challenge Project Coordinator in the amount of \$127,500; and

WHEREAS, the County will issue an 18-month contract, with the option to extend, with the Medical College of Wisconsin in the amount of \$350,847 for data analysis, integration, and storage; and
