A. The Milwaukee County Zoo requests approval to execute a professional services contract with Robert Zigman Marketing Inc. in an amount not to exceed \$190,000 per year to provide entertainment booking services for Milwaukee a la Carte for two years and two optional one-year renewal terms.

B. The Zoo's a la Carte event generates over \$1.1 million in revenues. This contract books the entertainment for the Zoo. Without the contract, the Zoo would not be able to generate the budgeted revenues. Funding for the out years will be requested in the upcoming budget requests.

C. The 2017 Budget includes funding for entertainment services.
