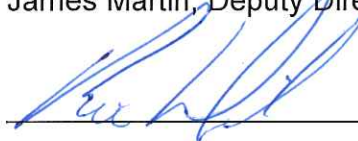

- A. The action being requested will result in execution of a contract between Milwaukee County and the Wisconsin Department of Transportation (WisDOT) to provide an additional bus on the Red Line route to maintain currently scheduled service intervals during Zoo Interchange construction between June and August 2017.
- B. By executing the contract, Milwaukee County (specifically, MCTS) will receive \$206,079 in operating revenue from WisDOT.
- C. Requested approval of this contract is contingent upon approval of a separately submitted appropriation transfer to establish expenditure authority and fully offsetting non-county revenue. With approval of the transfer, there would be no tax levy impact to Milwaukee County.
- D. Assumes approval of the separately submitted appropriation transfer.
