A substitute resolution by Supervisor Sebring, requesting authorization to amend Sections 68.01 and 71.12 of the Milwaukee County Code of General Ordinances by removing County Trunk Highway (CTH) K (West Old Loomis Road) from the CTH system, by recommending adoption of the following:

AN AMENDED SUBSTITUTE RESOLUTION/ORDINANCE

WHEREAS, the authority to make changes to the County Trunk Highway (CTH) system is granted to Milwaukee County (the County) by Section 83.025, Wisconsin State Statutes; and

WHEREAS, on September 26, 2013, the Milwaukee County Board of Supervisors (County Board) approved the transfer of jurisdiction of County-owned land adjacent to the Root River Parkway to the Department of Parks, Recreation, and Culture, containing CTH K (West Old Loomis Road) in its entirety; and

WHEREAS, on April 18, 2017, the City of Franklin (the City) Common Council adopted a resolution that conditionally approved a request to initiate the road discontinuance vacation process of CTH K (West Old Loomis Road) between:

1. Approximately 160 feet southwest of West Warwick Way and West Rawson Avenue
2. West Rawson Avenue and South 76th Street (Crystal Ridge Road)

; and

~~WHEREAS, the same April 18, 2017, resolution conditionally approved the County's request that the City of Franklin accept the jurisdictional transfer of CTH K (West Old Loomis Road) at the following location:~~

- ~~1. South 76th Street and approximately 560 feet northeast of Hollow Lane~~

WHEREAS, to accomplish the above, provided the conditions of this Resolution and the City's resolution are met, CTH K (West Old Loomis Road) will need to be removed from the CTH system by amending Section 68.01 and Section 71.12 of the Milwaukee County Code of General Ordinances; and

WHEREAS, the County Board, at its meeting of May 25, 2017, referred File No. 17-373 to the Committee on Transportation, Public Works, and Transit (vote 17-0); and

45 WHEREAS, the Committee on Transportation, Public Works, and Transit, at its
46 meeting of June 7, 2017, recommended adoption of a Substitute Resolution as
47 amended (vote 3-2); now, therefore,

49 BE IT RESOLVED, the Milwaukee County Board of Supervisors (County Board)
50 hereby authorizes the road discontinuation vacation process and jurisdictional transfer
51 as described herein upon approval of the Wisconsin Department of Transportation
52 (WisDOT), and pursuant to the terms and conditions of the authorizing resolution
53 passed by the City of Franklin (the City), contingent upon the required consent of
54 WisDOT, as outlined in Section 83.025(1)(a), of the Wisconsin State Statutes; and

56 BE IT FURTHER RESOLVED, the County Board hereby authorizes the
57 Department of Parks, Recreation, and Culture, the Department of Administrative
58 Services, the Department of Transportation, the Office of Corporation Counsel, and any
59 other Department that may be necessary to execute and record all documents and
60 perform all actions as required accomplish these tasks; and

62 BE IT FURTHER RESOLVED, the County Executive and the County Clerk are
63 authorized to execute any required documents regarding the execution of this
64 Resolution; and

66 BE IT FURTHER RESOLVED, that if all of the terms and conditions of this
67 Resolution and the City's resolution are met, the County Board hereby amends Section
68 68.01 and Section 71.12 of the Milwaukee County Code of General Ordinances, by
