25 26 27	WHEREAS, the existing Agreement inadequately protects the County and residents under the conditions of the increased development; and
28 29 30 31	WHEREAS, the Operator is considering a purchase of the former landfill property in the City of Franklin, but not the land zoned as parks in the Village of Greendale (Greendale); and
32 33 34	WHEREAS, mutual consent to cancel the existing Agreement has been requested by the Operator; and
35 36 37	WHEREAS, the ski hill in Greendale will be subject to a separate lease agreement and will not be sold by the County; and
38 39 40	WHEREAS, the Committee on Parks, Energy, and Environment, at its meeting of May 16, 2017, recommended adoption of File No. 17-366 (vote 3-1); now, therefore,
41 42 43 44 45	BE IT RESOLVED, the Milwaukee County Board of Supervisors (County Board) hereby authorizes the cancellation of the existing Sports Park Maintenance and Operations Services Agreement (Agreement) with The Rock Sports Complex, LLC (Operator); and

- 46 BE IT FURTHER RESOLVED, the County Board hereby authorizes the Director 47 of Economic Development, Department of Administrative Services (DAS), to negotiate a 48 lease agreement between Milwaukee County and the Operator for the Ski Hill property 49 located in the Village of Greendale on the terms and conditions contained within the 50 Term Sheet attached to this Resolution; and
