- A. The following position was requested in the 2017 budget and was removed to the Appropriation for Contingency through amendment 1A045. The Office on African American Affairs is requesting the creation of 1 position (Community Engagement Coordinator), and a DAS administrative fund transfer to remove the money from allocated contingency and place it into OAAA for the purposes of monitarily supporting the position.
- B. In 2017 the full cost will be \$38,645 which will be withdrawn from the appropriation for contingency through an administrative fund transfer.
- C. The budgetary impact in 2017 is \$38,645 from the Appropriation for Contingencies to support the position. There is sufficient dollars in 2017 to fulfill the requested action of creating 1.0 FTE because money was budgeted in 2017 but was moved to Allocated Contingency through Amendment 1A045.
- D. This fiscal note assumes the rate of pay for 12 pay periods of 2017 at Step 1 of Pay Range 26M
