The approval of the requested action will allow The Executive Steering Committee to negotiate and enter into a contract with Infor and its subcontractors to replace the County's current legacy Finance and Human Resource Management systems with funding through Capital Project WO602 Enterprise Platform Modernization.
- B. The current request for an amount not to exceed \$9,000,000 will allow The County to enter into a contract with Infor and its subcontractors which will include system purchase and implementation, data conversion and interface development, and testing and training for the new ERP system, as well as the first year of ongoing maintenance.
- C. The contract agreement with Infor and its subcontractors will result in a capital cost not to exceed a total of \$9,000,000 with \$7,800,000 being requested for the current year for software purchase and implementation and \$1,200,000 being requested for subsequent year 2018 annual ongoing maintenance.
- D. Infor's proposal has been used to estimate the purchase and implementation costs as well as the ongoing maintenance associated with the new ERP system. The information provided here is based on the currently defined project scope.
