I'd like to clarify my comment about personal risk in my email this morning. While obviously this would be decided by a judge, there is an exception to the immunity provision for ill-intended and malicious acts, especially those that conflict with the law - which the resolution passed today seems to embody. I raise this issue not as a threat but simply to highlight that rushing through issues like this exposes the County to increased risks of costly litigation and the potential loss of statutory exemptions like discretionary immunity. A measured approach to these issues is in everyone's best interests.

The only threat I see is the one against our department leaders - a direct threat to their take home pay that seems to target very specific people.
