 - (a) Between the limits of South 20th Street and South 27th Street.

- (2) South 76th Street (C.T.H. 'U')
 - (a) Between the limits of West Grange Avenue and West Layton Avenue.
 - (b) Between the limits of West Ryan Road and a point three-fourths of a mile north of Ryan Road.
 - (c) On the west side of South 76th Street (C.T.H. 'U'), from a point eight
