18 19 20 21	WHEREAS, on April 18, 2017, a staff member of the Audit Services Division (ASD), Office of the Comptroller, received a deposition subpoena in the matter of United States Eastern District of Wisconsin Case No. 2017CV156, <i>Daniel Black v. David Clarke, et al.</i> ; and
22 23 24 25	WHEREAS, in the months prior, ASD staff tried to interview staff of the Milwaukee County Sheriff's Office (MCSO) as part of an investigation per Section 34.095 of the Code, but MCSO denied the request; and
26 27 28 29 30 31 32	WHEREAS, on April 20, 2017, a contract was drafted for the ASD to retain Attorney Stadler of Mallery & Zimmerman to serve the ASD as legal counsel to represent the ASD at the April 26, 2017, deposition and to represent the ASD in an affirmative declaratory judgement action concerning its authority under Section 34.09(5) of the Code in conducting Milwaukee County (the County) investigations; and
33 34 35	WHEREAS, Attorney Stadler began to provide services related to the deposition subpoena on April 21, 2017, since the deposition date was quickly approaching and the ASD understood mistakenly that the contract was being signed; and
36 37 38 39 40 41 42 43	WHEREAS, on April 25, 2017, the Office of Corporation Counsel advised that a conflict of interest would likely exist if Attorney Stadler were to represent ASD in the case above relating to the Milwaukee County Board of Supervisor's (County Board) powers to grant authority to the ASD due to Attorney Stadler's ongoing representation of the County Executive in a separate case also relating to the County Board's powers and therefore the ASD should retain different legal counsel for the pending matters; and

44 WHEREAS, as authorized in File No. 17-324, the ASD has now retained different 45 legal counsel to represent the ASD in an affirmative declaratory judgement action concerning its authority under Section 34.09(5) of the Code in conducting County 46 47 investigations; and 48 WHEREAS, Mallery & Zimmerman has invoiced the ASD for services in an 49 amount of \$3,557.30 to represent the ASD at the April 26, 2017, deposition in the matter 50 of United States Eastern District of Wisconsin Case No. 2017CV156 Daniel Black v. 51 52 David Clarke, et al.; and 53 WHEREAS, the contract to retain Attorney Stadler of Mallery & Zimmerman was 54 never signed, so the Office of the Comptroller would need authorization to pay the 55 invoice: and 56 57 WHEREAS, the Committee on Finance and Audit, at its meeting of 58 59 September 20, 2017, recommended adoption of File No. 17-579 (vote 5-0); now, therefore, 60 61 BE IT RESOLVED, the Office of the Comptroller is hereby authorized to pay 62 Mallery & Zimmerman an amount of \$3,557.30 for legal services rendered without a 63 contract relating to the April 26, 2017, deposition in the matter of United States Eastern 64 District of Wisconsin Case No. 2017CV156 Daniel Black v.
