**Subject:** **Extension for a Temporary Assignment to a Higher Classification (TAHC) for Office of the Sheriff Personnel**

### **Policy**

Chapter 17.085 of the Milwaukee County Code of General Ordinances requires an extension of temporary assignment beyond 180 days be approved by the Milwaukee County Board of Supervisors.

### **Background**

The Milwaukee County Office of the Sheriff (MCSO) is requesting an extension of the following TAHC's through April 15, 2018 or until the positions are filled permanently:

Aaron P. Dobson to Deputy Inspector	expires 10/14/17
Daniel K. Dittberner to Sheriff's Office Captain	expires 10/14/17
Brad M. Lessila to Deputy Sheriff Lieutenant	expires 11/13/17
Thomas E. Beal to Deputy Sheriff Lieutenant	expires 10/27/17
Terina L. Cunningham to CO Lieutenant	expires 10/28/17

These requests are being made due to the current uncertainty in leadership within the Sheriff's Office. The extensions will allow for continuity of day to day operations until such time the appointed Interim Sheriff will be able to assess the candidate pool and make hiring decisions.

Daniel K. Dittberner to Sheriff's Office Captain


