## **DESCRIPTION OF FISCAL EFFECT**

DAS and Corporation Counsel are requesting 1.0 FTE Assistant Corporation Counsel position to be added to expedite the drafting and review of ERS plan administration changes.

B. The full 2017 cost of the Assistant Corporation Counsel position is roughly \$36,264 for the last six pay periods of 2017. A total of \$27,401 in salary, \$3,661 in pension, \$3,113 in health care and \$2,089 in social security. The salary is based off of pay grade 34Z, step 14 and the remaining pay periods after October 9<sup>th</sup> 2017. Annual health care costs are \$13,490 based on information received from the Comptroller's office on the cost of health care. Social security is 7.65% of salary and pension is 13.36% of salary. There may be an additional costs associated with supplies and a computer for this staff member. A fund transfer in this amount will be submitted in the October cycle transferring funds sufficient to cover these expenditures from the Department of Human Resources to the Office of Corporation Counsel. The 2018 cost of the positions will be included in the 2018 County Executive's Recommended Budget.

C. Discuss the budgetary impacts associated with the proposed action in the current year. A statement that sufficient funds are budgeted should be justified with information regarding the amount of budgeted appropriations in the relevant account and whether that amount is sufficient to offset the cost of the requested action. Assuming the fund transfer is approved, there is no fiscal impact for 2017. These position will be included in the County Executive's 2018 Recommended Budget. Provided these positions are adopted as a part of the 2018 Adopted Budget, there will be no future fiscal impact in the 2018 budget. The total annual cost of the position based on 2017 expenses is about \$157,140.

D. Describe any assumptions or interpretations that were utilized to provide the information on this form

The fiscal note assumes that the Assistant Corporation Counsel position is at Step 14 of pay grade 34Z. The fiscal note assumes 2017 costs for the last six pay periods of the year. The assumptions used above are that the positions are filled at the highest pay grade, thus the amount listed is the maximum budgetary impact.
