A. The Interim Director of the Department of Health and Human Services (DHHS) is requesting authorization to allocate approximately \$1,466,766 in anticipated 2018 Community Development Block Grant (CDBG) funding and \$1,257,077 in HOME funding.

- B. The HOME and CDBG funding is included in the 2018 DHHS Budget for the Housing Division.
- C. While recognizing that future Federal allocations of grant awards are always uncertain, it is anticipated that the Federal Department of Housing and Urban Development (HUD) will provide the grant revenue in 2018. In no case will program expenditures exceed available revenue. As a result, there is no tax levy impact associated with approval of this request.
