A. The Interim Director of the Department of Health and Human Services (DHHS) is requesting authorization to execute 2018 Delinquency and Court Services Division (DCSD) purchase of service contracts with community vendors.

Approval of this request will allow the Interim Director of DHHS to execute purchase of service contracts to continue the provision of contracted Community Service & Restitution Coordination, the Evening Reporting Center, Level II In-Home Monitoring Services with Optional GPS, Targeted Monitoring Services, Prevention and After Care, Shelter Care, Juvenile Educational Treatment Initiative (JETI), Peer Specialists, Community Connections Services, Community Accountability Panels for first-time juvenile offenders, Mentoring, the Youth Employment Program, and the Saturday Alternative Sanctions Program for the period January 1, 2018 through December 31, 2018.

- B. Total 2018 expenditures included in this request are \$9,412,857.
- C. There is no tax levy impact associated with approval of this request in 2018 as funds sufficient to cover associated expenditures are included as part of DCSD's 2018 Budget.
- D. This fiscal note assumes expenditures will not exceed the amounts authorized for these purchase of service contracts.
