From the Interim Director, Department of Health and Human Services, requesting authorization to execute Purchase of Service Contracts with various community-based provider agencies in the total amount of \$5,593,848 for adults with disabilities programing and children’s programing in the Disabilities Services Division for the period effective January 1, 2018, through December 31, 2018, by recommending adoption of the following:

**A RESOLUTION**

WHEREAS, the Interim Director, Department of Health and Human Services (DHHS), is requesting authorization to enter into 2018 Purchase of Service Contracts with community agencies for the Disabilities Services Division (DSD); and

WHEREAS, approval of the recommended contract allocations will allow the DSD, DHHS, to provide rehabilitation/treatment and support services to adults and children with disabilities in Milwaukee County in 2018; and

WHEREAS, the 2018 Adopted Budget for the DSD, DHHS, includes sufficient funding for the recommended allocations; and

WHEREAS, the Committee on Finance and Audit, at its meeting of December 11, 2017, recommended adoption of File No. 17-754 (vote 7-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes and directs the Interim Director, Department of Health and Human Services (DHHS), or her designee, to enter into Purchase of Service Contracts for the Disabilities Services Division, DHHS, for the period effective January 1, 2018, through December 31, 2018, with the agencies and in the amounts listed below:
