 - A. MCTS proposes extending Route 67 to South 84th Street and Layton Avenue to increase accessibility to employment, shopping and residential destinations. Extending the bus route about 1.5 miles decreases the frequency of the service along the route, but an overall increase in ridership is anticipated.
 - B. The same number of buses that are used on Route 67 will continue to be allocated to this route; therefore, costs will not increase. Ridership and revenue increases are expected to be nominal.
 - C. There are no budgetary impacts in the current year or subsequent year.
