A. The Zoo Director requests authorization to execute a support and maintenance agreement with KMIT for the Zoo's point-of-sale system.

B. In 2017, the Zoo completed implementation of a new point-of-sale system with KMIT for FocusPoint 360. In order to provide needed services to keep the system running smoothly, a service and maintenance agreement is needed. The IMSD 2018 Budget includes \$57,324 for this purpose. Future year budgets will include the following: 2019 - \$57,324, 2020-2022 \$61,736 per year.
