A. Section 301.031 of the Wisconsin Statutes requires counties to execute an annual contract with the State Department of Children and Families (DCF) for the "Community Youth and Family Aids Program." This program provides State funding for County services to juvenile offenders as mandated by State and/or Federal law. The Interim Director, Department of Health and Human Services (DHHS), is requesting authorization to enter into a 2018 contract with the State for the provision of juvenile justice services mandated by State law.

B. The 2018 contract provides \$42,628,935 in Youth Aids funding, which is \$238,668 higher than budgeted in 2018 and \$129,396 lower compared to the 2017 State contract. The reduction in the contract is the result of the Youth Aids formulae. Most notably, a decline in JCI placements is the primary driver of this reduction.

C. DHHS does not anticipate a budgetary impact in 2018. The additional revenue of \$238,668 compared to budget must be spent on the provision or purchase of delinquency or delinquency-related services for juveniles and their families.

D. No further assumptions are made. The revenue amount is reflected in the State contract.
