A. The Interim Director of the Department of Health and Human Services (DHHS) is seeking authorization to retroactively amend a 2017 purchase of service contract with Running Rebels for the Intensive Monitoring Program-Aftercare within the Delinquency and Court Services Division (DCSD).

B. The amendment would increase the existing 2017 contract amount of \$2,000,000, by \$40,000 to \$2,040,000. The amendment would be effective July 1, 2017 to December 31, 2017.

C. There is no 2017 tax levy impact associated with approval of this request. The increase would be funded through surplus 2017 Youth Aids revenue.

D. This fiscal note assumes expenditures will not exceed the amount authorized for this purchase of service contract.
