I. Summary

The Demanded Cuts of \$15.7 Million in County Board File 17-674 – 1A001 are in addition to the \$17.2 million of efficiencies found in administrative departments, the more than \$30 Million of efficiencies found in non-departmental accounts and other departments, and the hundreds of millions of efficiencies gained by the County since 2012. There is no doubt that the additional Demanded Cuts of \$15.7 Million will result in service cuts to Public Safety, Transportation & Transit, Social & Community Services, and Core Government Functions. The specific cuts necessary are documented in the attached table, and are summarized as follows:

¹ Amendment 1A001 required cuts in the amounts stated on the attached Table1. Later, Amendment 1A007 required that these cuts be covered by increasing the cost of inmate calls. The amount for House of Corrections, however, was insufficient to cover the full \$467,456, thus call rates would have to be increased to \$.27 per minute.

² Amendment 1A001 removed \$14.7 Million of VRF Revenue from the Department of Transportation. By removing this revenue, \$14.7 Million of tax levy would be needed to have no cuts to Transportation & Transit. In lieu of replacing this tax levy, Amendment 1A001 instead made \$8.28 Million of cuts to Department of Transportation, representing 56.3% of the total levy needed to restore services.

³ Cuts to Department of Aging of \$105,554 were made by Amendment 1A001 but restored by subsequent amendment, thus these cuts are not included on this list. Neither the County Executive, nor the Department Heads, recommend the cuts included in this report.

II. Background on Amendment 1A001

On October 6, 2017, Milwaukee County Board Chairman Theodore Lipscomb, Sr. requested a list of expenditure reductions of \$8,019,441.50 - \$20,048,603.⁴ On October 9, 2017 the Department of Administrative Services provided a list of the service cuts that would be necessary to reach the benchmarks set by the Chairman.⁵

On October 24, 2017, Amendment 1A001, sponsored by Chairman Lipscomb, Supervisor Peggy West, and Supervisor Michael Mayo was approved by the Finance Committee of the County Board. Amendment 1A001 demands specific expenditure reductions of specific departments totaling \$15,677,077.00 ("Demanded Cuts").

The cuts in Public Safety, Transportation & Transit, Social & Community Services, and Core Government Functions necessary to meet the Demanded Cuts are summarized in the attached Table 1: Expense Reductions Required by Milwaukee County Board File 17-674 1A001.

III. Background on Expense Reductions Prior to Demanded Cuts

Both the Public Policy Forum 2018 Budget Brief,⁶ and the Milwaukee County Research Division's 2018 Overview⁷ both highlight the revenue strategies in the budget, but neither go as far as Chairman Lipscomb's suggestion that the County Executive's Recommended budget did not include "any significant savings."⁸ These reports do not address the cost savings aspects because these reports focus on how the remaining gap is filled, after all of the savings have been identified, which is largely done in the departmental request phase. To suggest that the 2018 Recommended Budget did not include savings is a complete misrepresentation of the budget process. The budget process is a 12-month process with several phases, each of which identifies significant savings. The First Phase of "Administrative Cost to Continue" identified \$17.2 Million of efficiencies, and the Second Phase of "Other Cost to Continue" identified \$14 Million of efficiencies and \$30 Million of revenue; striking almost a 50/50 balance between expense reduction and revenue generation.

Again, the table from the Research Division's 2018 Overview only includes an identification of the revenue used to close the final gap. By its very nature it did not include the savings identified during the request phase. Had the charts been produced to show the entire budget process it would have shown the following:

Overview of Administrative Cost to Continue

The First Phase of cost savings is to estimate the additional centralized costs that cannot be controlled by the departments and need to be budgeted centrally. These include items like fringe benefits, insurance costs, facility costs, etc. The Comptroller's five-year forecast, together with actuarial reports are used to establish estimates. These items are annually summarized for the Board. For 2017, this information was included in File 17-91,⁹ and identified the 2018 gap to be between \$37.5 and \$54.7 million ("Centralized Cost to Continue"). This Centralized Cost to Continue is budgeted separately, and as a consequence each department is given a Tax Levy Target that is usually lower than the previous year. Each Department is then responsible for identifying efficiencies and service adjustments to meet the Tax Levy Target. In 2018, Administrative Departments identified \$17.2 Million in savings necessary to meet their Tax Levy Target ("Administrative Cost to Continue Efficiencies"). The cost cutting efficiencies included \$2 Million cost savings related to reduced administrative costs and other efficiencies in DOT-Transit, over \$12 million of restructuring in DHHS, and additional \$3 million of creative expense reductions from nearly every department throughout the County.

Overview of Other Cost to Continue

The \$17.2 Million discussed above is only the cost savings for the Administrative Departments. Each elected officer is responsible for making their own requested budget to the County Executive. Each year this information is presented to the public pursuant to Wis. Stat. §59.60(5).¹⁰ This year's 2018 Requested Budget Summary shows that the requests for funds exceeded the 2017 Recommended Budget by \$94.8 Million. This amount essentially represents the cost to continue for non-administrative departments and the centralized cost to continue (i.e. Fringe Costs, Insurance Costs, etc.). For the purposes of this memo, this is referred to as "Other Cost to Continue". There are some *new initiatives* that can be reasonably excluded from the \$94.8 million dollar figure, including a Sheriff's request for \$24.6 million above cost to continue, and various other requests for cash funding of capital projects for \$24.6 Million. The net result of Other Cost to Continue for 2017 is \$44 million.

Considering Previous Years Savings

When considering additional efficiencies it is important to note where we are in the stage of identifying efficiencies. Efficiencies will always be identified, but we are already six years into the process. In the past six years have County has saved millions of dollars each year. These savings have avoided significant service cuts. However, an additional Demanded Cut of \$14,733,602 cannot be achieved through efficiencies, and must ultimately come from service cuts.

In the last 5 years, the County has found efficiencies that have saved billions. For example, the restructuring that has been done in previous years to Other Post Employment Benefits (OPEB) has resulted in a projected savings of approximately \$40 million for 2018 alone and reduced the overall liability by over \$500 Million. Nearly 1,000,000 square feet of obsolete building space has been eliminated saving the County \$2 million per year in energy savings, and millions more in avoided capital expenses. Worker's compensation claims reforms have resulted in \$4 million savings annually. Other massive efficiency changes have included the centralization and modernization of procurement, work order systems, and many more.

The 2018 Recommended Budget included over \$30 million of efficiencies, on top of the hundreds of millions in previous years. The balance between efficiencies and new revenues in the County Executive's budget is nearly 50/50. The Demanded Cuts of \$15.7 million are in excess of these efficiencies and will negatively impact Public Safety, Social and Community Services, Core Government Functions, and Public Infrastructure Projects.

I. BACKGROUND

The Milwaukee County Board passed Amendment 1A001 ("Amendment 1") which required \$15.7 Million in cuts to specific departments in the 2018 Milwaukee County Budget.¹ The Milwaukee County Board also passed Amendment 1A035 ("Amendment 35") which requested:

Prior to enacting any direct service cuts, departments will work with the Department of Administrative Services – Performance, Strategy, and Budget to identify opportunities to re-organize, streamline, consolidate, eliminate, or otherwise reduce duplication and the cost of administrative expenditures within County government. The initiative shall include a review of prior internal and external audits, consulting reports, workgroup activities, and studies. In addition, the effort should include a critical reassessment of any expenditure of contract funds for non-core services.²

This due diligence has been completed and as stated above in Category 2 a total of \$8,336,953 of cuts can be administratively handled but will have an adverse impact on the 2019 budget and the delay of projects. Policy Issue

Pursuant to County Ordinance Sections 44.09(e), 46.09(8), and 56.30(8), attached is a summary of contract notifications received by the Office of the Comptroller during September and October 2017. This report includes professional service, purchase of service, memorandum of understanding, lease, public works, and revenue contracts, but generally not contracts issued by the Procurement Division. This report does not include employment contracts.

Under Wisconsin Statutes Section 59.255(2)(e), the Comptroller is required to determine whether funds are available prior to contract execution. My office receives contract notifications from departments at that time. This report is mostly based upon those notifications.

This report has five attachments:

- Attachment 1 – Exemptions – This section explains the coding system for contracts which are exempt from County Board review.
- Attachment 2 – Accounts Charged – For most contracts, the department must identify an account to which it will charge the expenditure. This section summarizes the accounts which frequently appear in the following section (Attachment 3).
- Attachment 3 – Main Contracts – This section summarizes main contracts including professional service, purchase of service, and most public works contracts.
- Attachment 4 – No Immediate \$ Impact – This section summarizes contracts that initially do not have a specific guaranteed dollar amount or contracts that do not involve an exchange of money. Examples include annual, time and materials, and educational agreements.

- Attachment 5 – Revenue Contracts – This section summarizes contracts in which the County will receive revenue. Examples include grant, concession, vendor, and certain lease and use agreements.

Exemption Types

A - Mental Health Board jurisdiction: Pursuant to Wis. Stats. 46.21(2)(j), the County Board “may not exercise approval or disapproval power over any contract relating to mental health or mental health institutions, programs, or services.” Furthermore, Wis. Stats. 51.41(10) requires “Any contract related to mental health with a value of at least \$100,000, to which Milwaukee County is a party may take effect only if the Milwaukee County mental health board votes to approve, or does not vote to reject, the contract within 28 days after the contract is signed or countersigned by the county executive.”

B - Contracts for services less than \$100,000 using funds only from this fiscal year: Wis. Stats. 59.52(31) authorizes the execution of a service contract with a value of less than \$100,000 without County Board or Finance Committee review unless that contract requires funds from a future fiscal year that has not yet been adopted. This applies to both professional service contracts under Milwaukee County General Ordinance (MCGO) Ch. 56 and to nonprofessional service contracts under MCGO Ch. 32.

C - County Executive jurisdiction: Per Wis. Stats. 59.17(2)(b)(3) and 59.52(6), without County Board approval, the County Executive may make all orders concerning County property and sell, acquire, or lease property on land that is not zoned as a park and the Transit Center parcel. The County Executive may also “construct, purchase, acquire, lease, develop, improve, extend, equip, operate and maintain all county buildings, structures and facilities” on land that is not zoned as a park and at the Transit Center. Generally a contract that uses funds from a future fiscal year that has not yet been adopted will require County Board approval, but a lease or an easement of land not zoned park or of the Transit Center that uses funds from a not yet adopted fiscal year will not require County Board approval.

D - Public Works contracts: These contracts do not require County Board review. Per the authority cited in Exemption C, above, public works contracts on land not zoned as a park are exempt from County Board approval, but are subject to the bidding requirements set forth in Wis. Stats. 59.52(29). Public works contracts on land that is zoned as a park shall be awarded pursuant to Wis. Stats. 59.52(29) and according to County Board policy as set forth in MCGO 44.14.

E - Procurement of personal property using only funds from this fiscal year: Wis. Stats. 59.17(2)(b)3. and 59.52(6)(a) authorize the County Executive to acquire non-park personal property including goods, supplies, materials, equipment, and commodities procured under MCGO Ch. 32. However, the County Board must approve any procurement that requires funds from a future fiscal year that has not yet been adopted.

F - Community Based Residential Facilities: Contracts with community based residential facilities are exempt from County Board approval under Wisconsin Statutes. Per Wis. Stats. 46.21(2)(j), the County Board may not approve or disapprove any personal service contract or any contract or purchase of the county human services director “that relates to community living arrangements, adult family homes, or foster homes and that was entered into pursuant to” an annual social services or youth corrections budget/contract that the County provides the State “regardless of whether the contract mentions the provider.”

G - Price agreements: Price agreements (also called blanket contracts) issued under MCGO Ch. 32 establishing a rate without guaranteeing a quantity do not require County Board or Finance Committee review.
