18 19 20 21 22 23 24	WHEREAS, one longitudinal study, the HighScope Perry Preschool Study, showed that adults at age 40 who were born into poverty but attended a high-quality preschool program had higher earnings, committed fewer crimes, were more likely to have graduated from high school, and were more likely to be employed when compared to adults that did not receive a preschool education; and
24 25 26 27	WHEREAS, the benefits of early childhood development programs provide immediate and long-term tangible benefits to the child as well as to the community; and
27 28 29 30 31 32 33	WHEREAS, for example, the benefit of a half-day preschool program for low income children resulted in benefits of \$7.10 for every dollar invested based on increased earning capacity, tax revenues, reduced spending on remedial education, and reduced criminal justice costs, according to a longitudinal study conducted by the Chicago Child-Parent Center Program; and
34 35 36 37 38	WHEREAS, in 2015, according to the National Center for Education Statistics, despite the benefits of preschool education, only 51 percent of three and four-year olds in the United States (U.S) were enrolled in full-day preschool programs, a number that has remained nearly static for the past 15 years; and
39 40 41 42 43 44 45	WHEREAS, Federal, state, and local government recognize the importance of early childhood development as evidenced by investments in programs like Head Start, a program of the United States Department of Health and Human Services that provides early childhood education, nutrition, and parent services to low-income children, and Early Head Start that serves pregnant women, infants, and toddlers to age three, as well as child care programs, early intervention programs, home visitation, child wellness, and more; and
