- A. The approval of the requested action item will allow the Office of Emergency Management to execute a Memorandum of Understanding (MOU) with Waukesha County Department of Emergency Preparedness/Radio Services (Waukesha County) for the governance, operation, and hosting of the jointly owned Shared Radio Core. This work is necessary for implementation of Milwaukee County Resolution #13-886, authorizing the Contract for Service with Motorola Solutions for the build-out of ten digital radio sites.
- B. This MOU will authorize a payment of \$75,000 to Waukesha County for costs associated with operation and maintenance of the Shared Radio Core that were incurred in FY 2016, and subsequent years thereafter with a 3% annual escalator. Payments to Waukesha County for the initial ten (10) year term total \$859,790.95.
- C. There are sufficient funds allocated in Office of Emergency Management's 2017 budget to cover the costs of the 2016 and 2017 payments.
- D. This MOU is necessary for the implementation of Milwaukee County Resolution #13-886, authorizing the Contract for Service with Motorola Solutions for the build-out of ten digital radio sites.
