## Policy

The 2018 Adopted Budget requested changes to Chapter 15, 47.031 and 47.32 of the Milwaukee County Code of Ordinances. The Milwaukee County Clerk and Corporation Counsel requested that the changes be submitted as separate files effective 1/1/2018.

## Background

Proposed changes to Chapter 47.031 remove the fees for Lincoln Memorial Drive from Ordinance. Each year the County Board approves a new fee schedule allowing for changes that are responsive to the local market. Removing the fees from ordinance reduces an additional administrative step each time the fees are changed.

## Recommendation

Authorize Parks to enact changes to Chapter 47.031 removing the fees for Lincoln Memorial Drive from Ordinance.


