53.03. - Organization of commission; membership.

The commission on aging shall consist of sixteen (16) members, with the total composition of the commission reflecting representation of at least eight (8) senior citizens sixty (60) years of age and over and representation of all segments of the elderly population: at least four (4) members shall reside in the suburbs of the county; at least four (4) members shall reside in the City of Milwaukee: at least one (1) member shall be a county board supervisor and one (1) member shall represent the health community. Current members of the commission shall maintain membership for staggered terms; such terms shall be for one (1), two (2) or three (3) years, effective upon implementation of this resolution and ordinance.
