Policy

Milwaukee County Parks (Parks) requests an update to Chapter 47.09 of the Milwaukee County Code of Ordinances.

Background

Proposed changes to Chapter 47.09 (Use of parks for aircraft prohibited except with permit) include the addition of unmanned aerial vehicles (UAV) and drones to the existing list of gliders, hot air balloons, parachutes, etc. whose use is not permitted without written permit of the director of Parks.

Recommendation

Authorize Parks to enact changes to Chapter 47.09 requiring permits for use of unmanned aerial vehicles (UAV) and drones within Parks.
