From the Chief Judge, First Judicial District, Combined Court Related Operations, requesting authorization to execute a contract with JusticePoint, Inc., in the amount of \$221,605, for the following Central Liaison Unit positions: Case Manager, Pretrial Investigator, and Peer Support Specialist, as outlined in the Bureau of Justice Assistance Award Grant, relative to the Justice Reinvestment Initiative: Assessment Technical Assistance and Maximizing Local Reforms, for an 18-month term, by recommending adoption of the following:

**A RESOLUTION**

WHEREAS, on September 30, 2015, Milwaukee County (the County) received notice of a Justice Reinvestment Initiative: Assessment Technical Assistance and Maximizing Local Reforms: Maximizing Local Reforms (Award Number: 2015-ZB-BX-0004), in the amount of \$281,185 for the period effective October 1, 2015, through September 30, 2018; and

WHEREAS, on December 17, 2015, the Milwaukee County Board of Supervisors (County Board) adopted File No. 15-752, which authorized the Chief Judge, First Judicial District, Combined Court Related Operations, to accept the Bureau of Justice Assistance Award Grant for the Justice Reinvestment Initiative: Assessment Technical Assistance and Maximizing Local Reforms: Maximizing Local Reforms (Award Number: 2015-ZB-BX-0004); and

WHEREAS, on March 27, 2018, the County received notice from the Bureau of Justice Assistance agreeing to a no-cost extension of the grant; and

WHEREAS, JusticePoint, Inc., was awarded the Central Liaison Unit contract through a competitive Request for Proposals (# 9816003) process that was approved by the County Board on November 7, 2016, in adopted File No. 16-643; and

WHEREAS, the Office of the Chief Judge will contract with JusticePoint Inc., to perform the duties of: Central Liaison Unit Case Manager, Pretrial Investigator, and Peer Support Specialist, as outlined in the grant application for a total of \$221,605 for a period of 18-months; and

WHEREAS, the Committee on Finance and Audit, at its meeting of May 17, 2018, recommended adoption of File No. 18-358 (vote 7-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes the Chief Judge, First Judicial District, Combined Court Related Operations, to execute a contract with JusticePoint, Inc., in the amount of \$221,605, for the following Central Liaison Unit positions: Case Manager, Pretrial Investigator, and Peer Support Specialist, as outlined in the Bureau of Justice Assistance Award Grant, relative to the Justice Reinvestment Initiative: Assessment Technical Assistance and Maximizing Local Reforms, for an 18-month term.
