IV. REFLECTION – Commissioner Elizabeth Meyer-Arnold, M.S., R.N.

Commissioner Meyer-Arnold's reflection was on "Waiting Through Change." Ms. Meyer-Arnold compared her thoughts of what was never seen before unusual, beautiful clouds patterns in Wisconsin which were drastically changing as well as herself. Humans are like the clouds, changing, unfinished, and a work in progress. Waiting through change is a real exercise in faith. MCDA is waiting for change and will be stronger as the department moves through change. Commissioner Meyer-Arnold ended her reflection by thanking MCDA staff and Commissioners for their hard work, and she also praised the dedicated advocates and public.

V. INFORMATIONAL ITEM: Milwaukee Public Schools – Senior Recreation Programs - Annie McGinnity Kubes, Recreation Coordinator, City Wide Programs and Willie Mitchell, Supervisor for Older Adult Programs gave a PowerPoint presentation. MPS' Senior Recreation Program serves two senior populations: one which is 80 years and older, and the other being 50 years and older. Activities are offered at MPS' social centers (field houses) and senior housing facilities located in the south and central areas in Milwaukee neighborhoods. A one-year membership fee for their Senior Center is \$15. The 50 years and older adults prefer the traditional community classes/programs offered in the evenings and weekends There are about 10,000 seniors that prefer to be a part of the adult classes and programs.

MPS Senior programming has experienced challenges with transportation for seniors. The Adult Enrichment programs offers fitness, classes, sports leagues, travel clubs, a senior center, community centers, and SeniorFest. - VI. INFORMATIONAL ITEM: Social Security Administration Office Social Security Issues and Resources Elena Gonzales-Walker, Public Affairs Specialist, Social Security Administration, and Maria Ramirez, District Manager for Greenfield Office of Social Security Administration Office: The Social Security Administration Office now has online Social Security services you can access instead of making a trip to the Administration Office. A few of the online services available are: Changing your home address, requesting to be direct deposited of your benefits, printing your yearly statements, and requesting a Social Security replacement card (Only if you possess a valid driver's license). Replacement cards take 7-10 business days to process and mailout. It is strongly recommended for ages 18 years and older to visit the Social Security website to check on your account and report suspicious activity to protect your Social Security number and benefits.
- VII. INFORMATIONAL ITEM: Milwaukee County Department on Aging MCDA's Area Plan Update and Next Steps, Carmen Pangilinan, Program & Policy Coordinator: Carmen Pangilinan has been working on gathering input from the public, caregivers, partners, Milwaukee County Department on Aging's' Councils and Committees, and staff by conducting listening sessions, having online and paper surveys, and most recently public hearings. Goals were created from the themes collected from the public input sessions for specific areas MCDA needs to target for their Area Plan: Elder justice, services and supportive for caregivers, dementia, healthy aging advocacy and nutrition. MCDA will create local priority goals from what seniors want in the community.

Ms. Pangilinan discovered transportation and senior centers were the two primary local priority goals. Also, staff created draft goals and presented them at the April 30th hearing. They included more about technology (smartphones, computers, etc.) and information on prevention programs: brain health, partnerships and collaborations. Ms. Pangilinan stated the Area Plan updates will be shared with the Commission and will be available soon on the MCDA website. Ms. Pangilinan would like everyone to provide her with their feedback via email or phone as she is open to speaking with

anyone who may have questions about MCDA's Area Plan goals. The new Area Plan will be submitted at the end of this year.

VIII. INFORMATIONAL ITEM: MCDA's Website – Rebecca Schmitt, Information & Outreach Coordinator: Milwaukee County is implementing website redesigns with all departments to create websites that will be very user-friendly and easy to access. Ms. Schmitt displayed a mock-up of the new County website design main webpages as well as MCDA's main webpage, and she discussed the functionalities of the new website. The new website will be automatically responsive to the device you are using to access the County's site. Currently, no launch date has been determined; however, Ms. Schmitt will keep the Commission informed as of the launch date. Chat functionality will not be available at the time of the launch, but it is something that was discussed and will be available possibly in the future.

XI. EXECUTIVE DIRECTOR'S REPORT:

- Milwaukee County Department on Aging Staffing: MCDA's Access Unit is fully staffed with the exception of an Access Supervisor position. There are two Call Center vacancies and one Human Social Worker vacancy in the Elder Abuse Unit.
- MCDA 2019 Budget Update: MCDA's Assistant Fiscal Director is working with staff to develop the Area Agency and Resource Center 2019 budgets. On July 14, 2018, all County budgets are due. Milwaukee County's Departments have not yet received their tax levy targets. Currently, the Commission does not have a new County Supervisor identified for the Commission. The County Executive's Office is working with MCDA to identify a new supervisor. MCDA has started a new intergenerational pilot project with MPS and Brown Street Academy. MCDA is working with older adults from Clinton Rose Senior Center to assist students in the classroom. The seniors and students love this pilot project; the plan is to start it back up in September 2018. Chairperson Sibley said it was a good program to expand to all senior centers.
- ➤ Volunteer Recognition Event: The volunteer recognition event was held last night at Davian's Event hall in Menominee Falls. There were about 200 volunteers in attendance. The event was very well-received. Ms. Davis thanked all her staff that was involved.

- **XII. COUNTY SUPERVISOR'S REPORT:** TBA The County Executive has not appointed a County Supervisor to serve on the Commission on Aging, so at this time there is no Supervisor's Report.
- XIII. STATE UPDATES: Neil Minogue, Older American's Act Program Supervisor for State Office on Aging:
 - > State Aging Advisory Council: Currently the State Aging Advisory Council has nine members and is in the process of looking for more members from the northern part of the state. Mr. Minogue thanked Holly Davis for attending and for introducing herself and the Department on Aging to the Council.
 - ➤ MCDA's Area Plan: Mr. Minogue has briefly reviewed MCDA's Area Plan goals; so far, they look good and are measurable.
 - Adult Protective Services (APS): The Bureau of Aging and Disability Resources applied for a grant to enhance Adult Protective Services' ability to document APS case and client information reporting systems. Also, Adult Protective Services is working on the supportive decision-making form related to Chapter 52. Chapter 52 allows individuals who are intellectually and/or physically disabled to understand their choices and decisions (a supportive decision maker).
- XIV. CHAIRPERSON'S REPORT: Barbara Wyatt Sibley, Chair
 - County Legislative Information Center, CLIC: As of June 2018, Committee and Council members will have to access meeting materials via Milwaukee County's Legislative Information Center (CLIC) found at http://county.milwaukee.gov/
 - Elimination of the Intergenerational Council and Resource Center Oversight Committee: The Executive Committee recommended that the Commission eliminate the Resource Center Oversight Committee and the Intergenerational Council because they have not been functioning for quite some time and the Executive Committee has a hard time finding leadership for these groups. MCDA will continue to have Intergenerational projects. Each Committee and Council should incorporate a diversity goal. The RCOC would be replaced with a representative from Milwaukee County at the state level, and the Commission will support MCDA's intergenerational initiatives with expanding intergenerational relationships within MPS and beyond.

MOTION: To eliminate the Intergenerational Council and the Resource Center Oversight Committee.

 - The County's Executive Office is working on the next round of Commissioner candidates. Currently there are three people who are being considered. The County Executive and Holly Davis are working to get a County Supervisor appointed to the Commission.
