County Board Resolution 17-320, adopted April 20 2017, approved funding in the courts budget, with the consent of the chief judge under the John D. and Catherine T. MacArthur Foundation Safety and Justice Challenge Phase II implementation grant award, for the creation of 1.0 FTE positions of district attorney Investigator for the County's Crisis Assessment Response Team. The position is used for aide of County residents experiencing mental health crises. The position started work on October 9<sup>th</sup> 2017. A December 2017 fund transfer provided budgetary authority for the 2017 salary and fringe benefits of the position.

This transfer seeks to provide budgetary authority for the 2018 personnel costs of the District Attorney CART Investigator and offsetting revenue from the courts though the MacArthur grant.

There is no tax levy impact from this fund transfer.

In April of 2018, the Wisconsin Department of Justice, Office of Crime Victim Services, made a one-time grant award of \$19,256 to the District Attorney's office, under the federal Victims of Crime Act (VOCA) program, to enhance services to crime victims.

VOCA program has a 20 percent local match requirement, which can be met by cash of in-kind match. This onetime VOCA grant has no tax levy effect because unpaid interns and volunteers working in the victim witness series unit are providing in-kind match to meet the 20 percent local requirement.

The grant provides some training funds for district attorney victim advocates and other general amenities for victim waiting rooms at the Sojourner Family Peace Center, and in the crisis response unit.

This fund transfer provides budgetary authority for the 2018 expenditures authorized by the one-time VOCA grant and for the receipt of offsetting VOCA revenue in the District Attorney's 2299 state grants account.

There is no tax levy impact from this fund transfer.

This transfer recognizes revenue awarded to the Milwaukee County Parks Department from two grant programs. The Milwaukee Bucks and American Transmission Company provided a donation of \$2,625 for the purchase of 35 trees through their Trees for Threes program. Milwaukee County Lake Park Friends provided a donation of \$4,000 for the purpose of funding an intern for Parks Natural Areas in 2018. This transfer also completes file 18-62 which converted work previously executed by contract through UW-Extension to a Restoration Ecologist county employee.
