Subject: Update on Improvements to Lincoln & Meaux Parks per the **2018 Budget Amendment (1A028)**.
(INFORMATION)

Background

The Department of Parks, Recreation and Culture is hereby providing an update on the improvements at Lincoln & Meaux Parks, which were possible per Amendment (1A028), approved in the 2018 Budget, which provided \$100,000 for Lincoln and Meaux Parks, to address chronic roadway flooding issues related to the pump house along the parkway that regularly fails due to the discharge pipe design and aging /failing equipment. In addition these funds were to be used to maintain and improve the existing playground bathroom, as well as reinstalling a drinking fountain at the basketball courts in Meaux and Lincoln Parks.

Summary/Scope of the work that will be performed:

Playground Bathroom: replace the following; exterior and interior doors, toilet partitions and plumbing fixtures. Paint interior and exterior of the facility and repair the roof.

Lincoln/Meaux Water Fountain: replace the drinking fountain with a stanchion fountain and install a concrete pad to elevate the fountain. In addition install concrete bollards to prevent future damage to the fountain.

Milwaukee River Parkway Flooding: repair electrical and operational issues within the pump house, bringing it to working order. Utilizing the remaining funds, Milwaukee County A&E's Department will investigate the pump discharge; which under high flood conditions, the pump discharges at the river water level.


