#### TENTATIVE AGREEMENT WITH

#### MILWAUKEE COUNTY

### June 20, 2018

The parties agree that the provisions contained in the 2015-2016 collective bargaining agreement between the County and the Local 1072 be continued in a new three year agreement, except as modified below. This tentative agreement is subject to ratification by Local 1072 and the County.

## 1. <u>Section</u>. 2.01 – SALARY

Delete (1) as no longer necessary.

2017: Effective pay period 1, increase wages 1.75% across the board.

2018: Effective pay period 1 increase wages 2% across the board.

2019: Effective pay period 1 increase wages 2% across the board.

### 2. Section 2.03 – EMPLOYEE HEALTH AND DENTAL BENEFITS

#### (1) Health Premiums

Effective 1/1/17 revise as follows:

- (a) Freeze employee contribution at the 2016 level for 2017. Effective on the date of execution for this agreement, the employee contribution shall be increased as follows:
- (b) Employees shall pay \$140.00 per month toward the monthly cost of an Employee only plan effective on the date of execution for this agreement and \$147.00 per month effective January 1, 2019.
- (c) Employees shall pay \$166.00 per month toward the cost of an Employee + Child/Children plan effective on the date of execution for this agreement and \$174.50 effective January 1, 2019.
- (d) Employees shall pay \$233.50 per month toward the cost of an Employee + Spouse plan effective on the date of execution for this agreement and \$245.00 effective January 1, 2019.

- (e) Employees shall pay \$260.00 per month toward the cost of an Employee + Family plan effective on the date of execution for this agreement and \$273.00 effective January 1, 2019.
- (f) Wellness Program: If the employee successfully participates in the voluntary County sponsored wellness program, the employee shall receive a monthly premium reduction equivalent to either 30% of the premium or \$50, whichever is less.

#### **Section 2.07 OFF DAYS**

- (1) Employees shall be granted 12 13 paid off days per year in lieu of holidays and personal days. Such days shall be selected by the employees on the basis of departmental seniority.
- (2) Employees shall be granted such off days during their first calendar year of employment as follows:

From January 1 through February 21	<del>12</del> 13	
From February 22 through April 24	<del>10-</del> 11	
From April 25 through June 5	<del>8</del> 9	
From June 6 through July 27	<del>6</del> 7	
From July 28 through September 1	5	
From September 18 through November8	3	
From November 9 through December 31	1

3. <u>Probationary Period</u>: Probation to be expressed in hours; 1456 hours with possible extension at 2912 at the discretion of the Chief.
